

Detailed Rules on the Refund of Tuition Fees

Article 1 (Purpose) These detailed rules stipulate matters concerning the refund of tuition fees for undergraduate or graduate students at Pohang University of Science and Technology (hereinafter referred to as “University”) who are unable to continue study due to illness, death, natural disasters, or for other unavoidable reasons.

Article 2 (Application Scope) These detailed rules shall apply to those who have been accepted by the University and paid tuition fees but decided not to enter the University and to the students who have enrolled and paid the tuition fees but have decided to withdraw.

Article 3 (Restriction on Refund) A refund of the tuition fees shall be made pursuant to Article 4; however, a refund of such tuition fees may be disallowed when a person who shall be dismissed from the University pursuant to the Statutes of the University wishes to withdraw from the University and when a special reason is recognized by the President of the University.

Article 4 (Refund Policies) ① If a cause for the refund of tuition fees occurs prior to the date of entrance into the University or the first day of a semester, the full amount of entrance fees and tuition fees already paid shall be refunded.

② If the cause for the refund occurs on or after the first day of a semester, the entrance fees shall not be refunded; tuition fees shall be refunded according to the following schedule:

1. Day 1 – Day 30 of a semester: Five sixths of the tuition fees
2. Day 31 – Day 60 of a semester: Two thirds of the tuition fees
3. Day 61 – Day 90 of a semester: One third of the tuition fees
4. Day 91 of a semester and thereafter: No tuition fees shall be refunded.

Article 5 (Refund Application Period) Deleted (August 8, 2003)

Article 6 (Mutatis Mutandis Application) The relevant laws and regulations shall *apply mutatis mutandis* to matters other than those stipulated in these detailed rules.

Addendum

These internal rules shall be established and take effect on March 1, 1996.

Addendum

These amended internal rules shall take effect on November 13, 1997.

Addenda

1. (Effective Date) These amended detailed rules shall take effect on June 1, 2001.
2. (Interim Measures) The Internal Rules on the Refund of Tuition Fees shall be superseded by these –

Addendum

These amended detailed rules shall take effect on February 9, 2002.

Addendum

These amended detailed rules shall take effect on August 8, 2003.

Addendum

These detailed rules shall be amended on October 15, 2004 and applied retroactively to September 1, 2004.

1. (Effective Date) These amended detailed rules shall take effect on February 1, 2012.
2. (Interim Measures) The provisions on the refund of tuition fees shall take effect on March 23, 2007.
